The comparatively wide target market and limited distribution channels of CHAMPION LOANS have been factors in assessing why the distribution conditions and restrictions will make it likely that consumers who purchase the Product are in the class of consumers for which it has been designed.

CHAMPION LOANS considers that the distribution conditions make it likely that consumers who acquire the Product will be in the target market because:

- the Product can only be distributed by CHAMPION LOANS to consumers who meet the eligibility criteria and are within the target market, and in compliance with relevant laws; and

- CHAMPION LOANS has procedures and processes in place to ensure that applicants who do not meet the eligibility criteria and who do not fall within the target market will not be approved for the Product.
